BACKGROUND INFORMATION:

This project involves the construction of a 15-inch diameter gravity sanitary sewer under I-96, which will allow the abandonment of the existing West Oaks sanitary sewer pump station and force main. The pump station was constructed in the 1990s following the collapse of the gravity sewer serving this area. Since pump stations require a significant amount of maintenance, replacement of the force main with a gravity sewer will reduce time and money spent on preservation. The new sewer will be bored under I-96, with minimum disruption to existing infrastructure.

OHM Advisors assisted the Engineering Division with developing the engineering design plans for this project. The plans were advertised for public bids on January 14, 2022. Two (2) bids were received and opened on February 10, 2022, following the solicitation period. L. D'Agostini & Sons, Inc. bid is recommended in the best interest of the City, as it is responsive and complies with all requirements of the bidding instructions. The award recommendation letter including the bid tabulation is attached. A summary of the bids is as follows:





Dear Mr. Ben Croy:

Sealed bids for the I-96 West Oaks Sewer Replacement and Pump Station Abandonment project were received and publicly read aloud on Thursday, February 10, 2022, at Council Chambers, at 10:00 am. Proposals were received by the City from two (2) bidders. We have reviewed and checked the bids, and attached the Bid Tabulation for your information. The lowest two bidders are as follows:

Contractor	TOTAL BID
L. D'Agostini & Sons, Inc.	\$826,735.00
Superior Excavating, Inc.	\$1,130,207.50

The project scope consists of installing approximately 430 feet of 15-inch gravity sanitary sewer under I-96 and abandonment of the existing West Oaks Pump Station with associated restoration work. The final engineer's estimate of probable construction costs was approximately \$530,000.

Based on the bids received and conversation with prospective bidders, we suspect the bid results are in part due to limited availability of materials and resources as well as complexities of the project. Additionally, after review of the bid packages, it was identified that the 36-inch casing pipe for the jack and bore significantly impacts the bid amount, making up 37% of the low bidder's total bid. It should be noted that there are a limited number of contractors who install jack and bore pipe at this size and length, which further impacts bid pricing.

L. D'Agostini & Sons is the apparent lowest responsible bidder for this project. L. D'Agostini & Sons has satisfactorily completed similar projects for southeast Michigan communities. We do not foresee construction prices decreasing in the short term. Therefore, we recommend award of this contract to L. D'Agostini & Sons in the amount of **\$791,735.00** per the unit prices bid for the project. Please note that this contract award amount is derived from the total bid amount of **\$826,735.00**, less the crew day cost of **\$35,000**.

The undersigned also agrees that for each and every calendar day that he may be in default of Substantial Completion of the Work, within the time specified in this Bid, the OWNER will suffer a damage of EIGHT hundred dollars (\$800.00) per day, and said OWNER shall be compensated therefore at the rate as liquidated damages in accordance with the Agreement.

In submitting this Bid, it is understood that the right is reserved by the OWNER to accept any bid, to reject any or all Bids, and to waive irregularities in bidding in the interest of the OWNER.
