

### BACKGROUND INFORMATION:

The Road Commission for Oakland County has issued a permit to the City allowing use of roadways under County jurisdiction for civic events. The permit is predicated upon the adoption of an Authorizing Resolution by the Novi City Council approving the event and agreeing to the terms of the permit.

The City of Novi will provide Department of Public Service workers to coordinate the closure and reopening of the roads, and Police Officers will provide traffic-controlling measures immediately before, during, and after the event. Representatives from the Michigan State Fair and Shriners will be overseeing the participants and staging the event. Grand River Avenue is expected to reopen no later than 11:30 a.m.

## RESOLUTION 2016 Michigan State Fair Detroit Shriners Parade

WHEREAS, the Detroit Shriners have requested a parade be held on Labor Day, Monday, September 5, 2016 from 10 – 11 a.m., which is the last day of the 2016 Michigan State Fair; and

**WHEREAS**, the parade will begin at the Novi High School west lot and travel north on Taft Road to Grand River Avenue and then travel west on Grand River Avenue and end at 46100 Grand River Avenue, Suburban Collection Showcase; and

**WHEREAS**, the City of Novi has been issued an annual permit, Permit No. E 56051 by the Road Commission for Oakland County to conduct civic events on roads under the jurisdiction of the RCOC; and

**WHEREAS**, the validity of the permit is conditioned upon adoption of an Authorizing Resolution by the Novi City Council for the event and a statement agreeing to the terms of the permit.

**NOW, THEREFORE, BE IT RESOLVED** that Mayor and City Council hereby authorize and support the 2016 Michigan State Fair Parade and will fulfill all permit requirements, save harmless, indemnify, and represent the Board of Road Commissioners against any and all claims for bodily injury or property damage, or any other claim arising out of or related to the 2016 Michigan State Fair Parade.

### ROAD CLOSURE PERMIT FOR BLOCK PARTIES AND PARADES

The South East Parking Lot is the designated waiting area for vehicles picking up Parade participants. A map of the Parade Route will be provided to all participants.

#### **Design Guidelines:**

The Parade has been developed to celebrate Michigan's Agriculture, Businesses, and Communities. Please keep this in mind as your organization designs and builds your entry. **All entries MUST adhere to the spirit of the Parade.** 

### Parade Guidelines:

The throwing or passing out of anything, including candy, pamphlets, literature, etc., is prohibited for safety reasons, including preventing children from running into the street.

Political campaigning is allowed but participants, including candidates, must ride in a vehicle and the passing out of campaign literature or other items is prohibited.

### Parking:

Parking will be available at both the Parade Staging Area (Novi High School) and the Parade Ending Area (The Suburban Collection Showplace). Parking is complementary for Parade participants as long as they arrive before 9:30 A.M. and if parking at the Suburban Collection Showplace, participants must enter through the East Main Entrance. After 9:30 A.M. normal parking rates will be charged. A shuttle will be available and traveling between both parking lots. Participants can also be dropped off at the Parade Staging Entrance.

### Weather:

The Parade will take place rain or shine, unless conditions are unsafe or unbearable for Parade participants.
