### BACKGROUND INFORMATION:

The Engineering Division completed the Parking Lot Inventory and Maintenance Plan in January 2014 to provide a coordinated plan to properly manage parking lot pavement for all city owned parking lots using an asset management approach. The rehabilitation of the parking lot at Fire Station #3 was recommended as a near term recommendation by the report and was approved for construction in the FY14-15 budget. The project also includes pavement reconstruction in those areas that show signs of structural failure and drainage improvements as necessary to prolong the life of the new pavement.

Seven bids were received and opened on April 8, 2015 following a public bid solicitation period. The lowest responsible bidder is Nagle Paving Company (Nagle). Nagle's bid is recommended as being in the best interest of the City as it is responsive (i.e., Nagle has complied with all requirements of the bidding instructions) and it is the lowest price. (OHM's award recommendation letter including the bid tabulation dated April 10, 2015 is attached). A summary of the seven bids is as follows:

The project was originally included in the budget for the Fire Department. The 3<sup>rd</sup> quarter budget amendment (considered elsewhere on this agenda) will move the remaining funds (\$75,980) from Fire's budget to Engineering's budget with the other parking lot projects that are currently budgeted. Additionally, the low bid of \$92,010, excluding crew days, is higher than the available budget for the project because pavement cores collected during design revealed that several areas require more expensive reconstruction rather than rehabilitation as was originally proposed; therefore, a budget amendment is required to add funds to the project for construction and construction engineering (proposed for award elsewhere on this agenda). The additional funds are being allocated from additional property tax revenue in excess of the amount budgeted. The following table summarizes the proposed budget amendment:

Sealed bids for the Fire Station No. 3 Parking Lot Improvements were received and publicly read aloud on Wednesday, April 8, 2015. Proposals were received from seven (7) bidders. The seven (7) bidders and their bid amounts are summarized below and in the attached bid tabulation. The Engineer's Opinion of Construction Cost for this project was estimated to be \$94,385. Please note that these amounts listed below include the cost of crew days (inspector days) for the project.

The project scope consists of re-construction of the existing asphalt parking lot at the Fire Station No. 3 site, including other miscellaneous improvements such as concrete sidewalk, concrete pavement repair, concrete curb and gutter, and minor grading and drainage related improvements. The work to be completed under this Contract includes the furnishing of materials, equipment, and labor necessary to complete the proposed work, as well as all necessary restoration in accordance with the specifications.

Nagle Paving Company located in Novi, Michigan, is the apparent low bidder. They have completed previous recent projects for the City, and have been successfully performing similar types of projects in this geographical region for a substantial period of time. Based on our opinion and discussions with City Staff, we recommend award of the Fire Station No. 3 Parking Lot Improvements project to Nagle Paving Company, in the estimated award amount of **\$92,010.00.** Please note that this award amount is derived from the total bid amount of **\$98,4**10

## Section 9 Fire Station #3

Fire Station #3 is located on parcel 50-22-35-127-001, at 42785 Nine Mile Road (see Figure 9.1).

The concrete pavement on the site is in very good condition. On a PASER rating scale of 0 to 10 (0 is poor condition and 10 is just constructed), it has a rating of 9.

Asphalt areas on the site are in poorer condition, with a PASER rating estimated at 4. The pavement exhibits extensive cracking. One area behind the station has siltation on the pavement, indicating that ponding is occurring on the pavement. The pavement in this area is very poor. There also is a drainage area on the front side of the building where runoff is entering the building.

We recommend joint resealing for the concrete pavement areas.

For the asphalt areas, reconstruction is recommended for most of the area. A portion of the lot behind the building where traffic not generally subject to traffic should receive cold milling and an HMA overlay. For the areas with drainage issues, curb and gutter can be added and runoff directed to unpaved regraded areas adjacent to the parking lots. The estimated cost for the recommended improvements is \$84,900.
