- Four (4) sets of folded plans are dropped off at Community Development Department for review.
- Field Inspections and Acceptance Tests will be performed by the Fire Department.
- A "Deferred Submittal Letter" from the Design Professional in Responsible Charge must be included with all plan submittals.**

**VIIa. Fee Clarification**

Fire alarm items shall include but not be limited to; manual pull station (each box), fire alarm signal devices (horn or bell), heat or smoke detectors, fire alarm control panel (FACP), sprinkler system (wet only), sprinkler system (wet and dry), and alterations/additions to existing systems.

**INSTRUCTIONS FOR COMPLETING APPLICATION**

**MAKE CHECKS PAYABLE TO CITY OF NOVI**

GENERAL: Electrical/fire alarm work shall not be started until the application for permit has been approved and issued by the City of Novi. All installations shall be in conformance with the State Electrical Code. **No work shall be concealed until it has been inspected.** Rough and final electrical inspection requests will be made at cityofnovi.org. When ready for these inspections, log onto website 24 hours in advance no later than 3:30 p.m. Fire alarm acceptance test and final fire alarm inspection requests will be made by calling for inspections 48 hours in advance at 248-735-5674. You will need the **job address and permit number** to request inspections. Any questions regarding the electrical portion can be directed to the Inspector between 8 - 9 a.m. and 4 - 5 p.m. Any questions regarding the fire alarm portion can be directed to the Fire Marshal at 248-735-5674.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED.**
