**SUBJECT:** Approval to award the construction contract for the Fire Station 5 Parking Lot Rehabilitation project to Asphalt Specialists, Inc., in the amount of \$125,879.

#### BACKGROUND INFORMATION:

Fire Station 5 is currently being used for emergency response operations by City Contractor Superior Air-Ground Ambulance of Michigan, Inc. The asphalt pavement onsite has approached the end of its life-cycle and needs replacement. Due to the heavy equipment used for these operations, deep strength asphalt will be used in critical locations to protect and increase pavement longevity. As part of this proposed project, a driveway approach off of 11 Mile Road will be constructed as well as a pathway perpendicular to the new approach.

Engineering staff advertised the plans for public bids on January 10, 2019. Following the solicitation period, five (5) bids were received and opened on February 6, 2019 – two bids were deemed unresponsive due to both companies not acknowledging Addendum #1 which included a revised Bid Tab. The companies that were deemed unresponsive were Ahern Contracting, Inc. and Allied Construction Company, Inc.


Asphalt Specialists, Inc., bid is recommended as being in the best interest of the City as it is responsive and complies with all of the requirements of the bidding instructions. Attached in the packet are the award recommendation letter and bid tabulation. The summary of the responsive bid tabulation is as follows:



Dear Mr. Melistas:

On February 6, 2019 at 2:00 p.m., construction bids were opened and publicly read at the City of Novi Civic Center for the Fire Station No 5 Parking Lot Reconstruction project. The project includes reconstructing the bituminous parking lot and the addition of an entrance off of 11 Mile Road.

The City Clerk's office received five (5) sealed bids for this project, with two bids considered incomplete. Three bids are considered to be responsive having submitted a bid compliant with all requirements. The apparent low bidder, Asphalt Specialists Inc., submitted a total bid of \$134,279.00. Following the bid opening, Spalding DeDecker reviewed all of the bids received, verified the calculations, and prepared the bid tabulation for the project (attached).

Based on a review of experience and references provided, Spalding DeDecker finds that Asphalt Specialists Inc. is qualified to perform the required construction.

It is our recommendation that the project be awarded to the lowest responsive bidder, Asphalt Specialists Inc. in the amount of \$125,879.00, which is the total bid of \$134,279.00 minus \$8,400.00 for crew days bid.

Upon award by the City Council, our office will coordinate the completion of the Contract Agreement, Bonds, and Insurance information with Asphalt Specialists Inc.
