BACKGROUND INFORMATION:


Each year, the City of Novi selects residential streets for reconstruction, repaving, repair, and/or rehabilitation based on PASER ratings, staff's field observations and resident concerns. Spalding DeDecker, engineering consultants to the City of Novi, helped develop a list of streets for the 2017 Neighborhood Road Program (NRP). The base bid includes four streets originally chosen as candidates for the program. These roads include Moorgate Street, Irvine Drive, Park Ridge Road and Kings Pointe Drive. Also included in Contract 1 are Concrete Panel Repairs on nearby streets which include Bertram Dr, Cherry Hill, Dunbarton Dr, Foxmoor Dr, Fuller Dr, Kimberly Ct, Porter St, Queens Pointe, Randall Court and Summer Lane.

A total of 7 bids were received and opened on April 26, 2017 following a public bid solicitation period. The lowest bidder was Mattioli Cement Company. Mattioli's bid is being recommended as being in the best interest of the City as it is responsive (i.e., Mattioli has complied with all requirements of the bidding instructions) and it is the lowest price. It is anticipated that this project will be substantially complete in the summer of 2017 with final completion and restoration in early fall of 2017.



Dear Mr. Melistas:

On April 26, 2017 at 2:00 p.m., construction bids were opened and publicly read at the City of Novi Civic Center for the 2017 Neighborhood Roads Program – Concrete (Contract 1). The project includes pavement repairs and reconstruction throughout the City of Novi.

The City Clerk's office received seven (7) sealed bids for this project, with each bidder considered to be responsive having submitted a bid compliant with all requirements. The apparent low bidder, Mattioli Cement Company, submitted a total bid of \$1,082,751.59. Following the bid opening, Spalding DeDecker reviewed all of the bids received, verified the calculations, and prepared the bid tabulation for the project (attached).

Based on a review of experience and references provided, Spalding DeDecker finds that Mattioli Cement Company is qualified to perform the required construction.

It is our recommendation that the project be awarded to the low bidder, Mattioli Cement Company, for the 2017 Neighborhood Roads Program – Concrete (Contract 1) in the amount of \$1,030,271.59, which is the total bid of \$1,082,751.59 minus \$52,480.00 for crew days bid.

Upon award by the City Council, our office will coordinate the completion of the Contract Agreement, Bonds, and Insurance information with Mattioli Cement Company.
