# SEMCOG invites public comment on the Bicycle and Pedestrian Mobility Plan for Southeast Michigan

SEMCOG, the Southeast Michigan Council of Governments, announces the 30-day public comment period for the *Bicycle and Pedestrian Mobility Plan for Southeast Michigan*.

The *Bicycle and Pedestrian Mobility Plan for Southeast Michigan* ensures that the region's nonmotorized system meets the transportation, quality of life, health, and accessibility needs of its residents and visitors, as well as the economic development priorities and goals of the region and local communities. The plan builds upon SEMCOG's 2014 *Bicycle and Pedestrian Travel Plan for Southeast Michigan*. Review the draft plan <a href="here">here</a>. Review the appendix <a href="here">here</a>.

### The plan includes:

- Regional Priorities Regional policies and recommended actions that guide implementation efforts.
- **Understanding Current Conditions** An overview of the region's bicycle and pedestrian system with a multi-layered analysis of regional data.
- **Local Implementation** Technical guidance and regional examples for communities looking to enhance the bicycle and pedestrian system.
- County Profiles Local planning context, data analysis, and maps for each of the region's seven counties. (Part of appendix document.)

The Bicycle and Pedestrian Mobility Plan for Southeast Michigan contains six regional policies to continue enhancing the system and meet the needs of the region:

- Connect and expand the network of walking and biking infrastructure in the region to provide a safe, comfortable, and convenient experience for people of all ages and abilities.
- **Ensure equitable access** to core services and regional destinations for pedestrians and bicyclists, including connections to other transportation modes.
- **Increase safety** for pedestrians and bicyclists with systemic approaches to roadway design, traffic operations, education, and enforcement.
- Promote healthy lifestyles and vibrant communities with expanded options for pedestrian and bicycle mobility, recreation, and tourism.
- Provide education to encourage broader participation and awareness of walking and biking issues.
- Ensure the sustainability of the bicycle and pedestrian network with collaborative planning and adequate funding for development and maintenance.

The *Bicycle and Pedestrian Mobility Plan for Southeast Michigan* is the result of stakeholder engagement and a Bicycle and Pedestrian Task Force, comprised of 70 representatives from local governments, state and federal agencies, nonprofit organizations, research and education institutions, and other organizations and stakeholders. The task force met five times over the course of a year-long planning process. Members of the task force established the framework for this plan, deliberating on regional priorities, policies, and actions. To complement the work of the Bicycle and Pedestrian Task Force, other existing committees and stakeholder groups were engaged, including the Southeast Michigan Active Transportation Committee and the Southeast Michigan Trails Action Team.

#### **CALL TO ORDER**

Meeting called to order at 6:03 p.m.

#### **ROLL CALL**

#### APPROVAL OF AGENDA

Member Staudt made a motion to approve the agenda. Member Maday seconded. Motion passed 3-0.

#### **AUDIENCE PARTICIPATION**

Members of the audience introduced themselves and had complimented the Committee on the work that went into the Annual Non-Motorized Prioritization packet.

#### MATTERS FOR DISCUSSION

#### a. Discussion of 2019-2020 Annual Non-Motorized Prioritization Update

Planner Komaragiri explained the update starting with Novi's long interest in providing an interconnected system of sidewalk and pathway networks throughout the City. Planner Komaragiri went on to mention the process on how items are prioritized by city staff.

- Member Staudt stated that there is still thirty-seven miles of networks to build and thirty-two miles that have been built over the time that the Walkable Novi Committee has been tracking the progress. The City has been making a lot of progress.
- Planner Komaragiri explained the Completed, Under Construction, or Budgeted table on page 3 of the update.
- Member Maday asked what tentative meant in the table. Planner Komaragiri
  explained that tentative means there is no budget assigned for the specific project
  yet and no action was taken on it yet.
- Member Staudt asked how much the city spends on the sidewalks and pathways each year. Staff will get the numbers as requested. Member Staudt clarified that he is looking for how much was spent in 2017, 2018, and 2019 on the sidewalk and pathway networks. Member Maday asked how much it would be to finish all the tentative networks. After discussion, that number could be roughly calculated by the numbers provided in the report. There were some questions regarding how

much the ITC trail would cost when completely finished. Director of Parks, Recreation, and Cultural Services Muck mentioned it was around \$6.5 to \$7 million. The City is planning an event around the estimated time of being completed, which should be in September.

Member Staudt made a motion to approve the Prioritization Update. It was seconded by Member Maday and it was approved 3-0.

Planner Komaragiri pointed out the last page in the update. The memo that explained the proposed sidewalk connections to the ITC Trail that are being budgeted for in 2020 and 2021.

The Committee discussed possible roadwork being done on 10 Mile Road in 2020 by the Oakland County Road Commission, between Haggerty and Meadowbrook. Member Staudt wanted to know if they would be installing the sidewalks, as well as working on the road, and Engineer Runkel stated that different options are currently being discussed with ROCC. It had been observed that bicyclists never seem to use the sidewalks and bike in the road in this area. An audience member mentioned he bikes along that road and it is unsafe. Committee members indicated bike lanes should be worked into the plan when the roads get updated next year.

## b. 07-11-19 Walkable Novi Committee Meeting Minutes

Member Maday made a motion to approve the Minutes. It was seconded by Member Staudt and it was approved 3-0.

### c. Non-Motorized Plan Update

Following discussion, Member Staudt made a motion to staff to change the scope of the RFP to better reflect the Committee's needs. It was seconded by Maday and approved 3-0.

#### STAFF UPDATES

#### 1. Planning Update

#### a. Chase Farms Parks and Trails

Member Staudt asked what the City's responsibility for this trail is.

• An easement showing the location of the trail and appears to allow the public to use the pathway. The document was read to say that it is the city's job to maintain it. It was noted that the trail is not on any park inventories. Chair Mutch explained the history of the development, Chase Farms, and the trail that runs through the development. A comment was made about what happens when trees fall onto the trail and whose responsibility is it to clean up. Director of Parks, Recreation, and Cultural Services Muck said he would get the Forestry Department to take a look at it and start maintaining the trail. It was also suggested to update the signs for the trail. Member Maday said that it is a great trail and the whole city should know about it and have access to it.

#### 2. Engineering Update

## a. Active Non-Motorized Project Portfolio for Engineering Division

Plan Review Engineer Richardson talked about the four proposed sidewalk segments connecting to the ITC Trail planned for 20/21. Plan Review Engineer Richardson also stated that the Engineering Department is looking for the prioritization of segments for the next three years.

 Member Staudt mentioned the Bosco Property and how that it is something City Staff should start thinking about. Member Staudt said the use of the fields could be enhanced if added segments to the ITC Trail were provided. • Comments were also made about looking at the top twenty list to see which pathways could be used as potential projects to start for the engineer's three year budget plan.

Anticipated improvements to 12 Mile Road were discussed, and whether there are plans to install sidewalks on both sides of the road.

• Member Staudt commented that if there are no plans for sidewalks, the city at least needs the option to pay to install sidewalks along that road.

Member Maday mentioned that concerns from residents should be prioritized and be brought up to the top of list of projects to start.

 Member Maday said that residents who contact City Staff directly or come to meetings to express concerns should be prioritized first.

# 3. Parks, Recreation, and Cultural Services Update

Director Muck provided an update on the ITC Trail. Staff is anticipating the project to be wrapped and completed by Labor Day. The City is also planning a community event to celebrate the trail at the end of September.

## **COMMUNICATIONS**

A resident wanted to make sure he supports and make connections at the Echo Valley neighborhood.

#### **AUDIENCE PARTICIPATION**

There was no audience participation.

#### **ADJOURN**

Member Maday made the motion to adjourn the meeting. Member Staudt seconded the motion. Meeting adjourned at 6:59 pm.

It was very nice meeting you. Pictures have been submitted of Grand River East of Old Orchard, between Brateman Medical Center, 40015 Grand River and the Jewelry Center 39955 Grand River, where the pedestrian sidewalk is missing. This stretch of land encompasses, two plots of land, the Scuba Shop and a vacant lot, about 100 feet, a small section.

Currently this section of land is number 86, on the list for a pedestrian sidewalk. Grand River speed limit is 45 mph, 2 lanes each way, with a turn lane in the middle. The speed of traffic creates a vacuum pulling you into the street. I have seen children riding their bikes to the Mobile Gas Station on the corner of Haggerty and Grand River, close to the road due to no sidewalk and am concerned for their safety.

This section of land is used by Old Orchard, Applegate I, Applegate II, Novi Place all condos, and homes east of Old Orchard. Any help in expediting this section of land from number 86 to number 1 for a pedestrian sidewalk would be greatly appreciated, in keeping our Community Safe and Healthy.

Hi Sri,

Thanks for the quick follow-up. The issue of dogs on the trail is much more serious than even stated by residents. The issue of people not picking up after their pets is awful. On recent hikes on the trail, we found dog droppings right on the pavement in many places. Here's the thing about signage: If you put a large sign regarding an issue at the mile entry points to the trail, then walkers on the trail can say to someone," Hey, didn't you see the sign at Ten mile that says, "No Motor Vehicles Allowed?" That is helpful, and that sign is already at Ten Mile. But on my last Bike ride about a week ago, there still wasn't a large "No Motor Vehicles Allowed" sign at Nine Mile Road so there is no notice to reinforce there. I called the police on the 4x4 drivers last fall because they were really flooring it out and narrowly missed regular bikers. I strongly recommend "Pick up after your pet" signs at each end of the 2000 foot boardwalk. It is awful to have to watch where you step there instead of enjoying the view of the woods because of irresponsible pet owners. Signs don't cost very much. Thanks again for all your help!

Hi John,

I spoke with Jeff Muck, our Parks director about the three items that relate to Parks.

- 1. We discussed the blind curve one of the residents raised a concern. Jeff noted that one of the following can be done:
  - a. We can trim the shrubbery as suggested ,or
  - b. Install a sign reminding bikers to slow down due to the curve
- 2. We also discussed the concern about the unleashed dogs. Installing reminders at intermittent locations may not be feasible for various reasons. However, we are open to installing a reminder when the path gets too close to people's backyards like in your case. We will keep that in mind for our next maintenance upgrades. Please keep in mind that any changes or installation within ITC Corridor would require ITC's approval.

You can always call the Novi PD non-emergency line if you have any concerns with trespassing anytime.

I spoke with Rebecca about the proximity of future sidewalk to your proposed hardscape improvements. She will consider that as part of the ROW review for the sign permit.

I will reach out to the DPW regarding two items that were discussed at the meeting. I will keep you posted on these items.

- 1. Construction costs/grant amount for ITC Trail construction
- 2. Contact for RCOC in response to one of the resident's concern about raised pavement. He noted that the when RCOC repaved Ten Mile Road, the access slope to his driveway was compromised.
- 3. One of the residents also raised a concern about the lack of turning radii at Woodham and Ten Mile Road intersection. Please see image below. If there is anything you want to add here to provide clarification, please do.


