#### WALLED LAKE LAKE IMPROVEMENT BOARD MEETING MINUTES November 13, 2012

The meeting of the Lake Improvement Board for Walled Lake was held at the Novi Civic Center at 45175 W. 10 Mile Road on November 13, 2012. The meeting was called to order by Dave Galloway, Chairman, at 4:00 p.m.

Present: William Burke, City of Walled Lake Brian Coburn, Secretary-Treasurer, City of Novi Dave Galloway, Chairman and Riparian Representative Karen Warren, Oakland County Water Resource Commissioner's Office Philip Weipert, Oakland County Board of Commissioners Representative

#### Also

Present: Mark Roberts (Attorney, Secrest Wardle), John Sellinger with Savin Lake Services, George Rourk (resident)

Chairman Galloway opened the meeting and then asked for Public Comment. There was one member of the public that spoke regarding the lack of weeds given the lower lake level this year than in previous years.

# Moved by Coburn, Supported by Weipert; CARRIED UNANIMOUSLY: To approve the Minutes of September 25, 2012 meeting.

Secretary-Treasurer Coburn presented the Treasurer's Report for the third quarter of 2012 and quarter to date for fourth quarter. The balance on hand as of November 8, 2012 is \$29,355.23 and includes the 2012 assessment payment from City of Walled Lake and the payments made to date in the City of Novi. Coburn noted that the Novi income includes prepayments for future years and that the final fourth quarter report will include a note with an approximate total.

Galloway introduced the weed survey performed by Savin Lake Services. John Sellinger with Savin Lake Services discussed the lake survey work that had been completed to date which included maps showing the location of native weeds and Eurasian milfoil. Sellinger summarized the program that had been completed in 2012 which included one round of harvesting and two rounds of herbicide, which he believed to be effective for reducing the amount of weeds in the lake. Sellinger said that a full report would be delivered to the Board by the end of 2012 for use in setting up the 2013 program.

Galloway asked if they survey noted any Starry Stonewart. Sellinger responded that it was not noted in Walled Lake but other lakes in the area do have it. Galloway wanted to thank Jerry Anderson with Lakes Area Homeowners Association for his assistance in surveying the lake and coordinate the contractor's work.

Board members asked Sellinger some questions regarding the treatments and it was noted that Sellinger believes that the Board in on track to manage the weeds in the lake.

Coburn presented the proposed 2013 budget which includes \$97,435 in income and expenses. Coburn noted that there was a contingency of 15% held, that \$5,000 is allocated to lake management consultant for water quality testing and another weed survey in fall 2013, \$1,500 allocated to the permit fee for herbicide treatments, \$3,000 allocated to legal and administrative services based on the 2012 projection, leaving \$73,320 for lake treatments.

# Moved by Weipert, Supported by Coburn; CARRIED UNANIMOUSLY: To approve the Walled Lake Improvement Board 2013 budget as presented.

There was discussion regarding extension of the existing contracts for herbicide and harvesting to Savin Lake Services. Coburn noted that the 2012 contract allowed for the extension of the contract at the Board's discretion with a 3% increase in unit prices. Mark Roberts advised the Board that given that provision the contract could be extended.

# Moved by Weipert, Supported by Coburn; CARRIED UNANIMOUSLY: To exercise the option to extend the 2012 contracts with Savin Lake Services for herbicide and harvesting of Walled Lake in 2013 under the terms of the 2012 agreement.

Galloway asked for public comment and one member of the public spoke regarding the duration of the lake board and asked if the effort needed to continue past the current 5 year assessment. Mark Roberts explained that although the Lake Board was created by resolution from each City for a period of five years, the Board can continue on past the five years and prepare a new engineering report and new assessment roll. He suggested that the Board look at a four year roll to coincide with the term of the riparian representative under the statute. Coburn noted that the Board should seek resolutions of support from each City before continuing with another roll.

There was a discussion about the County Commission representative and redistricting that would take effect in January 2013. Mark Roberts noted that the statute only requires a representative from the County Commission, not necessarily the Commissioner that represents the district in which the Lake Board is located. Weipert stated that once the Commission meets the various assignments to boards and committees will be made.

Galloway stated that he has received complaints from residents about the rate at which the drawdown has occurred. Warren noted that the residents should contact the Water Resource Commissioner's maintenance personnel to complain. Galloway stated that he would like to see a coordination of police patrols on Walled Lake between Novi and the City of Walled Lake. Coburn noted that concerned residents should contact the City.

**ADJOURNMENT:** There being no further business to come before the Lake Board, the meeting was adjourned at 4:44 p.m.

## MEMORANDUM

TO:WALLED LAKE IMPROVEMENT BOARD MEMBERSFROM:BRIAN COBURN, P.E.; SECRETARY/TREASURERSUBJECT:CERTIFICATION OF DELINQUENT ASSESSMENTSDATE:SEPTEMBER 18, 2013

On June 17, 2010, the Walled Lake Improvement Board approved Resolution #3 (attached) which confirmed the special assessment roll. Paragraph 6 of the resolution requires that the City Treasurer for each city report any delinquencies to the lake board including the parcel number and the amount of delinquency.

The attached reports have been provided by the City Treasurers for Walled Lake and Novi reporting that a total of \$5,285.25 from 137 parcels is delinquent for the City of Walled Lake and that \$4,547.75 from 44 parcels is delinquent for the City of Novi. Interest on the delinquent assessments is set by paragraph 5 in Resolution #3 as 0.5% per month beginning February 14, 2012. The interest accrued through September 1 for Novi delinquent payments for the City of Novi is \$136.35. Walled Lake did not report the accrued interest amount.

The Lake Board is required by paragraph 7 of Resolution #3 to "certify the delinquency to the City Assessing official for the City in which the property is located, who shall then report the delinquency to the City Council." The delinquent sum and accrued penalties plus an additional penalty of six percent of the total amount reported would then be reassessed on the City's annual tax roll.

A motion from the Lake Board is necessary to certify the delinquent amounts plus interest for the City Assessing official for each City.

#### **RESOLUTION CONFIRMING ASSESSMENT ROLL**

#### RECITATIONS:

It has been determined that the Walled Lake Improvement Board will implement a five year aquatic weed control program for Walled Lake (the Project).

The Project is intended to make annual improvements to Walled Lake through the year 2015 at a total cost estimated to be \$518,615.00 for the benefit of the properties identified in Exhibit 1, which properties together shall constitute The Walled Lake Improvement Board Special Assessment District, hereinafter referred to as the "Lake Board SAD", and for administrative purposes to be known as SAD 175 in the City of Novi and SAD 175 in the City of Walled Lake.

Plans for the Project, the estimated cost of the Project, and the special assessment district boundaries were approved by Resolution of the Walled Lake Improvement Board following a public hearing on November 5, 2009. The Lake Board resolution further directed the Assessors for the City of Novi and for the City of Walled Lake to prepare a proposed assessment roll, which was considered by the Lake Board at its March 25, 2010 public hearing and the continuation of the public hearing on May 20, 2010.

In accordance with the direction of the Walled Lake Improvement Board following the March 25, 2010 public hearing and the continuation of the public hearing on May 20, 2010, the

City Assessors have prepared a revised special assessment roll allocating the total cost of the Project, less the City of Novi's voluntary contribution to the Project in the amount of \$30,000.00, to the property within the Lake Board SAD and the Assessors have filed such roll with the Lake Board.

A public hearing to review the revised special assessment roll was set and duly noticed in accordance with law for the purpose of hearing objections to the revised assessment roll.

The public hearing was conducted in accordance with the notice, and the Walled Lake Improvement Board determined that it would be appropriate to approve and confirm the revised assessment roll.

#### NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The revised special assessment roll for the Walled Lake improvement Board Project, the Lake Board SAD, in the total amount of \$488,615.00 (\$97,723.00 annually for years 2011 through 2015), attached as Exhibit 1 to this resolution, shall be and is hereby adopted and confirmed, and shall be collected from the properties benefited within the Lake Board District.

2. The Walled Lake Improvement Board Secretary/Treasurer is directed to endorse on the assessment roll the date of this confirmation.

3. All amounts of an assessment shall be assessed against each parcel of land in the Lake Board SAD as described on the Special Assessment Roll (Exhibit 1) to be due and payable in five installments, the first to be due on the <u>14th</u> day of <u>February</u>, <u>2011</u>, and the several subsequent installments shall be due and payable successively in intervals of twelve (12) months from the due date of the first installment.

4. The Clerks for the Cities of Novi and Walled Lake are directed to attach their warrants as required by law to the roll and to direct the roll, with their warrants attached, to the respective

City Treasurer. The City Treasurer for the Cities of Novi and Walled Lake shall thereupon collect the special assessment from those properties listed in Exhibit 1 which are located within each City's jurisdiction in accordance with the terms of this Resolution, the warrant, and the statutes of the State of Michigan.

5. Any portion of an assessment which has not been paid on or before the <u>14th</u> day of <u>February</u> of the tax year shall be considered delinquent by the City Treasurer for the City in which the property is located and shall accrue penalties at the rate of  $\frac{1}{2}$  of 1% for each month or fraction of a month that the assessment remains unpaid before being reported to the City Council for reassessment upon the City tax roll.

6. The City Treasurer shall report to the Lake Board on September 1 following the date when the assessment or any part of the assessment became due any delinquencies by submitting a sworn statement listing the names of the delinquent persons, if known, a description of the parcels of land upon which there are delinquent assessments, and the amount of the delinquency, including accrued penalties computed to September 1 of the year.

7. If the City Treasurer reports as delinquent any assessment or part of an assessment, the Lake Board shall certify the delinquency to the City Assessing official for the City in which the property is located, who shall then report the delinquency to the City Council in which the property is located to reassess on the City's annual tax roll of that year the delinquent sum and accrued penalties plus an additional penalty of six percent of the total amount reported.
