BACKGROUND INFORMATION:

Liquor licenses are subject to both a special land use approval under the zoning ordinance and approval of a license under the City Code. *Under both ordinance provisions, the Council is required to make findings to support the grant or denial of the request.*

Special Land Use Approval

The approval of a Special Land Use by the City Council requires findings in support of the City Council's decision. The standards for review under the zoning ordinance for special land use are:

- (1) The proposed establishment will promote the city's economic development goals and objectives, and will be consistent with the city's master plan and zoning ordinance;
- (2) Given the character, location, development trends and other aspects of the area in which the proposed use or change in use is requested, it is demonstrated that the use will provide a service, product, or function that is not presently available within the city or that would be unique to the city or to an identifiable area within the city and that the addition of the use or proposed change in use will be an asset to the area.
- (3) The use or change in use as constructed and operated by the applicant is compatible with the area in which it will be located, and will not have any appreciable negative secondary effects on the area, such as:
 - (a) Vehicular and pedestrian traffic, particularly during late night or early morning hours that might disturb area residents.
 - (b) Noise, odors, or lights that emanate beyond the site's boundaries onto property in the area on which there are residential dwellings.

- (c) Excessive numbers of persons gathering outside the establishment.
- (d) Peak hours of use that add to congestion or other negative effects in the neighborhood.
- (e) Fighting, brawling, outside urination, or other behavior that can accompany intoxication.

A public hearing was held on September 8, 2022, in the Novi Civic Center for consideration of the Special Land Use (SLU) request for approval for service of alcoholic beverages at Tapper's Fine Jewelry, Inc. in accordance with Ordinance No. 18-266 which added Section 2525 to the Novi Zoning Ordinance. The Planning staff had previously reviewed the required application and Site Plan and found the documents to be complete. Charles Boulard, Community Development Director, Jeff Herczeg, Director of Public Works, and Jan Ziozios, Deputy Assessor, considered the request in accordance with the standards for review specified in Section 2525.d of the Zoning Ordinance and determined to forward a **recommendation to City Council for approval of the Special Land Use**.

City Code License Approval

They City currently has seven new Class C quota liquor license available. Chapter 3 of the City Code contains the review criteria for considering a new license. Section 3-13 establishes the City's general licensing policy, which considers whether the facility:

- (a) Will provide a service, product, or function that is not presently available within the city or that would be unique to the city or to an identifiable area within the city.
- (b) Is of a character that will foster or generate economic development or growth within the city, or an identifiable area of the city, in a manner consistent with the city's policies.
- (c) Represents an added financial investment on the part of a long-term business or resident with recognized ties to the city and the local community.

In addition, Section 3-15 (g) establishes specific criteria, evaluating the application with regard to:

The applicant (subsection [g][1]), such as:

the applicant's management experience in the alcohol/liquor business

The facility (subsection [g][2]), such as:

- compliance with building, zoning, and other code requirements
- effects on traffic
- effects on surrounding businesses and neighborhood
- proximity of the proposed business facility to other similarly situated licensed liquor facilities

Benefits to the community (subsection [g][3])

- effects upon the economic development of the city
- effects on the health, welfare, and safety of the general public

- 1. whether the applicant has demonstrated a public need or convenience for the issuance of the liquor license for the business facility at the location proposed, taking into consideration, among other things:
 - 1. total number of licenses for similar establishments and/or operations in the city; and
 - 2. proximity of the establishment to other licensed liquor establishments
- The uniqueness of the facility contrasted with other existing or proposed facilities
- The permanence of the proposed facility in the community.

Section 3-17 of the City Code allows for an agreement on the prohibition on profiteering by Class C liquor license holders. Under the terms of the agreement, the City Council shall not approve the transfer of a Class C liquor license within three (3) years of the date of the original issuance of the license. A draft agreement is included in this packet.

The Police Department has no objection to the request. The Fire Department has no objection to the request, pending compliance with City regulations.

We represent Tapper's Fine Jewelry, Inc. ("Tapper's") in liquor licensing matters. Enclosed please find Tapper's Fine Jewelry, Inc.'s City of Novi Liquor License Application.

Tapper's is requesting a Class C Quota license from the City of Novi. The Michigan Liquor Control Commission ("MLCC") has allocated seven (7) additional Class C quota licenses to the City of Novi ("City"). These additional quota licenses have been allocated to the City because of a population increase in the City as of the 2020 federal census.

Please note that Tapper's has not yet filed their application with the MLCC, as this is a quota application. The Commission will not take any action on a quota application until the City's resolution of approval is received. 1. PSLU22-0006 - 20800 HAGGERTY ROAD PARCEL NUMBER 50-22-36-476-003

The applicant **Tapper's Fine Jewelry, Inc.** is requesting Special Land Use approval at **20800 Haggerty Road**, parcel number **50-22-36-476-003**. The applicant is requesting approval for use of the parcel for service of alcoholic beverages in accordance with Section 4.89 of the Zoning Ordinance.

Tapper's Fine Jewelry Inc. is asking for a Special Land Use approval for the service of alcoholic beverages. The Attorney for Tapper's, Hans Rentrop, stated that Tapper's is a fine jewelry store that currently has two other locations, one in Somerset and one in West Bloomfield. Both locations also have a liquor license. Mr. Rentrop said the general use of the store is the sale of high-end jewelry, Tapper's has been around for 44 years, and have been very successful. The process of sale is a customer comes into the store; they are greeted by a sales representative to discuss what it is that they are looking for. Alcohol is not served with everything; there is a refreshment bar, with cookies, coffee, water, and pop as well as alcohol. The number one source of sales for the refreshment bar are water and coffee, alcohol is the secondary. There are people who come in for engagements and anniversaries who buy a glass of champaign want to have a certain experience and to do something special. Tapper's does have a small bar or refreshment stand with five or six seats in the stores. The entire premises would be licensed so customers can walk around the store as they are being shown jewelry and other items. Mr. Rentrop stated every drink must be purchased; they are not gifted. Because of the way it is laid out and its hours of operation, this is not a bar or a restaurant. It does not have any typical things one would see or associate with bars or restaurants, or the things that can occasionally happen at those establishments. Tappers has never had a liquor license violation and do not ever want a liquor license violation. Tappers does not want anything to interfere with their main focus which is retail sales. Katrina Barbey wanted to emphasize that the sale of alcohol is just to enhance the experience for the quest. She stated in their business they do celebrate special moments with their guests, and they get to be a part of that. The liquor license would allow guests to be able to celebrate with a glass of champaign or wine. It is not given to every person who walks in the door, typically when alcohol is served, they have moved into an office for a private consult. At that point they know what they are shopping for and want to enhance their experience. Ms. Barbey stated they have operated like this at their

other two locations, and it has been a beautiful experience and they have been able to manage it very well. Tappers wants to be able to bring this experience to their Novi location and go above and beyond regular retail store refreshments and enhance the customer experience. Ms. Barbey stated they take the training and protocol very seriously and that is why they have not had any violations and have been successful. Paul Rujan explained that on a training level all the stores follow state and local guidelines. He stated that anyone serving alcohol is TIPS certified and has gone through all the training for that certification. Mr. Rujan said for their managers in each location have a food safety management license too, as a precautionary. Typically, managers are also TIPS certified. Mr. Rujan stated that as of now they have a two-drink limit.

Charles Boulard opened the public hearing, no one was present, and the hearing was closed.

Charles asked what the volume of alcohol consumed through a typical year would be? Katrina Barbey stated it is mostly a handful of drinks a week, with maybe one a day that they end up serving. Hans Rentrop stated he believes that it is less than 1% of sales. Jeff Herczeg stated the only question Public Works would have would be about the water usage with this service. But that it sounds like it would be a limited difference and would be no different than the use of an employee break room. Mr. Herczeg stated he has no objections. Jan Ziozios stated she has no questions and no objections. Charles Boulard stated he wants to make sure that no employees would be partaking in the drinking of alcohol during their working shifts. Paul Rujan said no, employees will not be partaking in the drinking of alcohol, and they have very strict rules.

Jan Ziozios made a motion to approve based on the findings that the information provided in the narrative establishes the approval criteria in the Ordinance. Jeff Herczeg seconded the motion.

The motion is approved on a 3-0 voice vote.

IN CASE NO. PSLU22-0006, Motion to recommend approval, based on finding that the information in the narrative establishes that:

- 1. The proposed establishment will promote the City's economic development goals and objectives, and will be consistent with the City's master plan and zoning ordinance
- 2. Given the character, location, development trends and other aspects of the area in which the proposed use or change in use is requested, it is demonstrated that the use will provide a service, product, or function that is not presently available with in the City or that would be unique to the City or to an identifiable area within the City and that the addition of the use or proposed change in use will be an asset to the area.
- The use or change in use as constructed and operated by the applicant is compatible with the area in which it will be located and will not have any appreciable negative secondary effects on the area.

Motion approved 3-0 Voice Vote. The hearing was adjourned at 10:14 AM
