To approve an Addendum to the Valencia South Planned Rezoning Overlay (PRO) Agreement, to clarify the authority of the City's landscape architect to authorize additional plantings within the conservation area/tree replacement area of the PRO Plan, in order to improve screening from adjacent properties, subject to final review and approval of the language of the Addendum by the City Manager and City Attorney.

Member Mutch asked City Planner, Barb McBeth if she would explain where the locations of the replacement plantings will go and what will be removed. She replied that it was near the southwest corner of the Valencia South development. There is a conservation easement area that had quite a bit of woodlands in it. That area was slightly lacking in terms of screening, especially during the winter months. They will plant 5 - gray dogwood shrubs and also 9 - white pine trees, 7 of which will be in the southwest corner and two further to the east. The white pines are consistent with some of the other screening trees that they have been placing there. Member Mutch pointed out that the pine trees will provide a larger screen than a shrub and add additional screening than if it was left in its natural state. He also mentioned that they were going to remove a 10" black walnut tree as well and wondered what the rationale was for that. Ms. McBeth said that was correct. City Attorney, Tom Schultz said it was specifically called out to Landscape Architect, Rick Meader and he reviewed the plan and proposals. The tree wasn't useful to screening and it was better to remove and replace it. Member Mutch asked Ms. McBeth what type of communication they have had with residents in that area. Ms. McBeth said that the Mr. Meader had been out to the site staking the locations of the trees. She wasn't sure if there has been additional contact with Pinnacle Homes or the homeowners at this Member Mutch wondered if the request came from Pinnacle Homes to add the additional screening. Ms. McBeth said she believed so. Member Mutch asked if it was in response to the adjacent residences and their concerns, or was it just Pinnacle Homes deciding that they also wanted some additional screening in this area. Ms. McBeth said it was in response to the residents' concerns. City Manager Auger said the residents have been working with staff to get the 80% opaqueness that everyone had agreed to. Member Mutch said he would reluctantly support this based on additional detail from staff regarding what was going on. He said the landscaping that is being proposed will better meet the screening desires of the residents. His big concern was the removal of a large amount of vegetation and trees that had been far beyond what he expected. He said particularly at 10 Mile and Beck, there were areas on the site

plan that weren't shown as being disturbed but have been clear cut. The fact that residents have been in communication with staff and Mr. Meader was involved, it sounded like the screening being proposed is better than what currently exists there. He will support moving this forward.

Member Markham would not be supporting this proposal. This development from the beginning was a PRO which is a vehicle that is good for the developer and also good for the city. This was one of the last continuous habitat corridors. She said it was her understanding that they were going to try to put in a development that would use the features of the development as an asset. That is not what happened. She has been hearing concerns from residents about what has happened to 10 Mile and Beck, and they are not happy. The natural vegetation that should have been able to be used is not there. She understood that this is going to make it a little better, but she said she felt it was putting a band-aide on it. She said she was very disturbed with how this whole process has gone. This was a beautiful corner and it could have been a premier development. They crammed as many houses as they could and destroyed natural features.

Member Casey wondered, since they were very specific about types of plants, was there any wiggle room. Ms. McBeth said there may be some flexibility. Member Casey said she was very grateful to staff for taking residents' concerns seriously as it relates to the screening. The whole reason that this amendment is before them is because the way the original agreement was written, the conservation easement was not to be touched. In order for the screening desired, they have to remove a very small numbers of bushes and one particular tree, and that is the only reason they are having the conversation on the amendment. She wondered if they have a sense of confidence that that nothing else will be removed to get those nine trees planted. She wanted to make sure there was no intent to do anything further in the conservation easement other than the screening. Mr. Schultz confirmed there was no intent to do that. He said they had the right to plant the additional trees when Mr. Meader looked at the actual condition on the ground, in order to plant those trees and make them work, a few things had to be removed. Member Casey thought the agreement was very specifically worded and very clear, but she wanted to make sure everyone was on the same page.

Member Mutch said he thought it would be helpful if administration noted the changes of what is being proposed in terms of the scope of the properties being involved. City Manager Auger explained that after the Public Hearing, the assessor looked at the roll and removed all of the streets that the residents said they didn't want to be a part of this project. All of those have been removed and it is back to the main three streets. City Manager Auger said that they can remove streets, but cannot add streets to the roll once it is started, which is why they were included to begin with. Member Mutch said the compromise with the streets that directly adjoin the streets that are being repaired he felt was fair and equitable.

panels would be repaired. He also wondered if this was the total program for 2017. City Manager Auger replied yes it was the total for 2017. Assistant City Manager Cardenas said it was about 900 for the first year. Mayor Pro Tem Staudt said that's within limits they wanted.

Mayor Pro Tem Staudt wondered how the bids came in compared to what was anticipated. Assistant City Manager Cardenas said they came in where they estimated. Mayor Pro Tem Staudt asked if they knew the average cost per panel. Assistant City Manager said the square footage is about \$1,000 per panel.

Member Mutch noted that over a dozen neighborhoods will benefit from areas all over the City. He also noted the locations that city administration made a point to address the entrances that were in really bad shape. Tackling those entrances is a positive first impression for people going into those neighborhoods. He said the residents complain about the traffic and also the condition of the roads. He mentioned the taxpayers and voters gave the city additional resources a couple years ago with the road millage to tackle more neighborhood roads. This is demonstrating City Councils' commitment to that.

Mayor Pro Tem Staudt commented that when they went to single hauler with larger receptacles, the residents were concerned about the size of the receptacles and storage. This is in a direct reaction to that.

Member Mutch said it was discussed at Ordinance Review Committee. Mayor Pro Tem Staudt touched on challenges they discussed. It is difficult for people with a single car garage with everything else that needs to be stored in there, yet Novi is a community that has high standards. They like to have neighborhoods clean and presentable. Having garbage containers on the street one day is ok because they are getting picked up. When the containers are out for a week or extended periods of time, that is

not the image the City wants to project to our residents, visitors, or future homeowner's. They felt this was a good balance. This moves containers to side, rear or in the garage, but recognizes that it's a little more flexible. He agreed with Mayor Pro Tem Staudt that they will see how it goes and we can revisit if it's not meeting the needs of the majority.
