BACKGROUND INFORMATION:

The City of Novi Fire Department currently utilizes Avon ISI for all of the Self-Contained Breathing Apparatus (SCBA). These SCBA packs were purchased in December 2006, making our ISI DXL packs 13 years old. The SCBA cylinders that supply air to the packs will expire after 15 years, which is June of 2021. These cylinders must be replaced as they cannot be recertified or tested after 15 years in service. The National Fire Protection Agency (NFPA) recommends that all Self-Contained Breathing Apparatus should be replaced every 10 years. Currently, all of our packs are in proper working order, but they have surpassed NFPA's recommended lifespan. At the May 6, 2019 City Council Meeting, City Council approved the replacement of the SCBA equipment in Fiscal Year 2018-19.

After thorough research and evaluation on multiple SCBA manufacturers, the MSA G1 unit was given the best overall rating. The benefits of the pack include; thermal imaging camera on every pack, 15 year warranty on every part of the SCBA, 5 year warranty on the thermal imaging camera, and has programmable electronics that allows packs to be put in a training mode for real life simulations. Apollo Fire Equipment is a sole source for MSA and the City of Novi Fire Department would be able to join the price consortium with Troy Fire Department. This purchase will include; 45 SCBA's, 100 masks, 100 mask bags, and four RIT Packs. Also included in this price is all of the technician level training for maintenance of the packs, computer software and shipping.

Overview

The City of Novi Fire Department currently utilizes Avon ISI for all of our Self-Contained Breathing Apparatus (SCBA). These SCBA packs were purchased in December 2006, making our ISI DXL packs 13 years old. The SCBA cylinders that supply air to the packs will expire after 15 years, which is June of 2021. These cylinders must be replaced as they cannot be recertified or tested after 15 years in service. The National Fire Protection Agency (NFPA) recommends that all Self-Contained Breathing Apparatus should be replaced every 10 years. Currently, all of our packs are in working order, but they have surpassed NFPA's recommended lifespan.

After several months researching multiple SCBA manufacturers, the City of Novi Fire Department was able to secure demo SCBA packs from the top three SCBA manufacturers; MSA, SCOTT and the AVON. This gave our team members the ability to make a comprehensive assessment on how the SCBA will function for us as a Department. All duty crews, both Full and Part-time members, were able to utilize all three of the manufacturers SCBA's during training and in simulated drills at the stations.

After each member utilized the SCBA pack, they were able to go online and submit an SCBA evaluation form. This gave them the opportunity to list the pros, cons and comments for each SCBA they tried out. The survey was live for a month to give each of our member's ample time to try out each pack.







Recommendation

After reviewing all the team members' evaluations and comments, the MSA G1 as shown in figure 1 was given the best overall rating by the majority of all evaluations submitted. The benefits of the pack include; thermal imaging camera on every pack, 15 year warranty on every part of the SCBA, 5 year warranty on the thermal imaging camera, and has programmable electronics that allows packs to be put in a training mode for real life simulations. Apollo Fire Equipment is a sole source for MSA and the City of Novi Fire Department would be able to join the price consortium with Troy FD and bring the cost of the MSA SCBA's to \$338,103.61. This will include; 45 SCBA's, 100 masks, 100 mask bags, and four RIT Packs. Also included in this price is all of the technician level training for maintenance of the packs, computer software and shipping.
