SUBJECT: Approval of a resolution supporting a No Left Turn restriction located at the intersection of Grand River Avenue and the private portion of Eleven Mile Road.

SUBMITTING DEPARTMENT: Department of Public Works, Engineering Division

BACKGROUND INFORMATION:

The Novi Town Center owner, CBRE, is requesting a No Left Turn restriction at the intersection of Grand River Avenue and the private portion of Eleven Mile Road (signed as Clear Drive by Town Center), for the purpose of preventing stacking on Eleven Mile and in parking areas. The Police Department and the Engineering Division are supportive of this restriction to improve the flow of traffic. The Road Commission for Oakland County will issue the Traffic Control Order for the required signs, but they have requested a resolution of support to confirm the City's approval of the turn restriction.

RECOMMENDED ACTION: Approval of a resolution supporting a No Left Turn restriction located at the intersection of Grand River Avenue and the private portion of Eleven Mile Road.

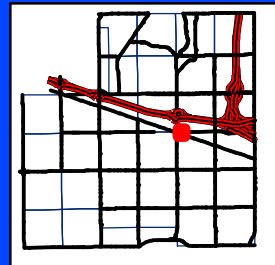
Town Center No Left Turn Location Map
