BACKGROUND INFORMATION:

The City of Novi's Information Technology Department currently maintains a backup of over nine terabytes of digital data to meet the requirements of the City's Disaster Recovery Plan and Continuity of Business Plan. Our existing solution has reached the end of life stage. Additionally, the manufacturer has raised the support costs by more than double. In an effort to reduce cost and leverage advances in technology the Information Technology team reached out to public and private entities to review their backup methodologies. Several were very forthcoming about their positive experiences with the Barracuda Networks product line. Barracuda Networks, an Ann Arbor, Michigan based company, offered a solution at a reasonable price point for the City of Novi.
